# An Emissions Data Base for Integrated Assessment of Climate Change Policy Using GTAP

## 1. Introduction

To facilitate integrated assessment of climate change policies with GTAP, we intend to compile an emissions data base compatible with the standard GTAP configuration. We plan to cover the three major greenhouse gases—CO<sub>2</sub>, methane and nitrous oxide—in this emissions data base. This work is part of a US-EPA sponsored project. Although the focus of this project is on non-CO<sub>2</sub> emissions, a useful starting point involved incorporation of CO<sub>2</sub> emissions from fossil fuels in the data base. Subsequent drafts of this paper will add non CO<sub>2</sub> emissions and net GHG emissions from land use changes.

## 2. Calculating CO<sub>2</sub> emissions from fossil fuel combustion

We first calculate CO<sub>2</sub> emissions from the GTAP energy volume data base<sup>1</sup> following the Tier 1 method of the revised 1996 IPCC Guideline (IPCC/OECD/IEA, 1997). To this first draft<sup>2</sup>, we summarize CO<sub>2</sub> emissions and energy consumption of the following countries:

- (1) Australia (see Tables 1a and 1b);      (2) China (see Tables 2a and 2b);
- (3) Japan (see Tables 3a and 3b);      (4) Taiwan (see Tables 4a and 4b);
- (5) India (see Tables 5a and 5b);      (6) Canada (see Tables 6a and 6b);
- (7) United States (see Tables 7a and 7b);      (8) France (see Tables 8a and 8b); and
- (9) Germany (see Tables 9a and 9b);      (10) The Netherlands (see Tables 10a and 10b).

Next we explain how we calculate CO<sub>2</sub> emissions from the GTAP energy volume data. The procedure for calculating CO<sub>2</sub> emissions from the GTAP data base entails the following procedures.

- A. We follow the Tier 1 method as suggested in the revised 1996 IPCC Guidelines (IPCC/OECD/IEA, 1997) to estimate CO<sub>2</sub> emissions, based on the GTAP energy volume data. The formula to calculate CO<sub>2</sub> emissions is as follows:

$$\text{CO}_2_{isjr} = \left( \text{FC}_{isjr} \times \text{CC}_i \times (1 - \text{CST}_{ijr}) \times \text{EF}_i \times \text{FOC}_i \times \left( \frac{44}{12} \right) \right) / 1000, \\ i \in \text{EGY\_COMM}, s \in \text{SRC}, j \in \text{ALLSEC}, r \in \text{REG}. \quad (1)$$

Set EGY\_COMM contains six energy commodities by GTAP classification: coal, crude oil, natural gas, petroleum products, electricity, and gas;  
set SRC refers to two sources of commodities: domestically-produced and imports;  
set ALLSECT contains all producers and households; and  
set REG contains all 66 regions of GTAP version 6 data base classification.

We opted to calculate CO<sub>2</sub> emissions from the GTAP energy volume data base to ensure an internal consistency in terms of classification of uses as well as consistency between values and volumes.

Coefficients are defined as follows:

$\text{CO}_2_{isjr}$ :  $\text{CO}_2$  emissions (Gg) from energy commodity  $i$  of source  $s$  used by sector  $j$  of region  $r$ ;

$\text{FC}_{isjr}$ : fuel consumption (1000 toe) of energy commodity  $i$  of source  $s$  by sector  $j$  of region  $r$ ;

$\text{CC}_i$ : conversion coefficient (TJ/1000 toe) of energy commodity  $i$ ;

$\text{CST}_{ijr}$ : ratio of carbon stored of energy commodity  $i$  used by sector  $j$  of region  $r$ ;

$\text{EF}_i$ : emission factor (tones Carbon/TJ) of energy commodity  $i$ ; and

$\text{FOC}_i$ : fraction of carbon oxidized of energy commodity  $i$ .

(TJ: Tera Joule; Gg: Giga- gram; 1 Gg =  $10^3$  tonne)

GTAP-commodity-specific values of coefficients CC, EF, and FOC are listed in Table A1.

- B. Coefficient CST in Equation 1 accounts for fuels used as feedstocks—natural gas and petroleum products used by petrochemical sector. Ratios of feedstock usage of the petrochemical sector are derived from the energy balance tables (OECD/IEA, 1999a; OECD/IEA, 1999b). We list the feedstock ratios in Table A2 in the appendix. For some non-OECD countries whose feedstock ratios are not available, we use as proxies the feedstock ratios of adjacent countries. This is an arbitrary assumption that adjacent countries may have similar technology of production. We will replace the assumption with specific information when it is available.
- C. Primary energy commodities are largely used for energy transformation. We specify non-zero values of CST to avoid double-counting of  $\text{CO}_2$  emissions for energy transformation activities. Due to dearth of information, we arbitrarily assume unity for the CST's corresponding to energy transformation activities.
- D. Table a of each country shows  $\text{CO}_2$  emissions from and volume of energy consumption by sectors (following classification of GTAP version 6 data base). Unit of  $\text{CO}_2$  emissions is giga-gram (Gg). Unit of energy consumption is ton of oil equivalent (toe).
- E. Table b of each country shows the significance of  $\text{CO}_2$  emissions from all energy-using economic activities.
- F. Energy consumption volume is from the GTAP energy volume data of 1997.
